4TH ANNUAL WOMEN'S CITY TOURNAMENT of the YUBA SUTTER USBC ASSOCIATION

QUALIFICATIONS and ELIGIBILITY REQUIREMENTS

This tournament consisting of Teams, Doubles, Singles and All Events, is open **ONLY** to **WOMEN** Yuba Sutter USBC Association members. This is a USBC certified event and USBC Rules will prevail unless so noted. Non-USBC members living in the jurisdiction of this association may bowl by buying an associate USBC membership for \$17.00. **THIS TOURNAMENT WILL BE HELD AT NU GENERATION LANES, YUBA CITY, CA.**

CLOSING DATE FOR ENTRIES and PAYMENT:

1. All entries must be in the hand of the Tournament Director no later than **thirty (30) minutes before squad time.**
2. Entries will be scheduled as received.
3. **Make checks /Money Orders payable to "YSUSBCA" . There will be a \$25.00 service charge on returned checks!**

MULTIPLE PARTICIPATION is allowed subject to the following to cash:

TO PLACE MORE THAN ONCE IN THE PRIZE LIST:

1. Team - At least two (2) players in the lineup must be different. (USBC Rule 315b1)
2. Doubles - At least one (1) player in the lineup must be different. (USBC Rule 315b2)
3. Singles - The same individual may not place more than once. (USBC Rule 315c)
4. Bowler's first appearance in each event counts toward the All Events total. (USBC Rule 315d)

ALL EVENTS:

1. Payment of participation fee for " ALL EVENTS " is optional. Prize fund will consist of "ALL EVENTS " fees collected.
2. An All Events champion who has not paid their " ALL EVENTS " fee is entitled to the trophy or award other than cash (USBC Rule 306d).

AVERAGES:

1. Entrants shall use the following entering average.
 - a. Highest January 1, 2010 league average of 21 games or more.
 - b. Highest 2008-2009 winter book average.
 - c. Highest 2008-2009 summer book average.
 - d. Highest Current league average of 12 games or more as of February 20, 2010.
 - e. If none of the above applies, bowler **MUST** bowl scratch of 220.

HANDICAP:

- a. Handicap in this tournament is 90% of 220 for Singles, 90% of 440 for Doubles and 90% of 880 for Teams.
- b. USBC Rule 327c. A tournament game or frame(s) within a game that is irretrievably lost in the scoring process will be rebowled unless there is an appeal made to YSUSBCA for consideration in accordance with Rule329b.

SUBSTITUTES:

1. Substitutes will be accepted subject to conditions of the multiple participation and average rules listed above.
2. All substitutes must report to the Tournament Director at least thirty (30) minutes prior to bowling.

DISBURSEMENTS:

1. Prize ratio will be at least 1:5 for each event. Prize fund returned 100%.
2. ***NO REFUNDS UNDER ANY CONDITIONS!***

CAPTAINS RESPONSIBILITIES and PROTESTS:

1. Squad times will be posted at least four (4) days in advance of the tournament. **Team Captains must notify teammates.**
2. Team Captains must check in team thirty (30) minutes prior to squad time.
3. **In case of protest report to the Tournament Director, ROSEY WHITTEN immediately!!**
